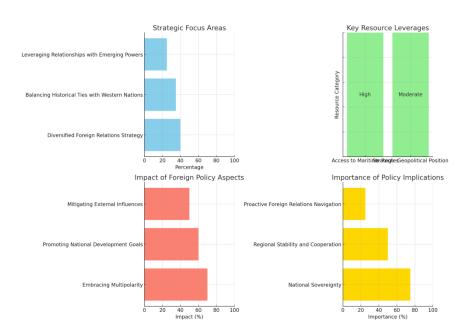


Figure 1: Strategic areas

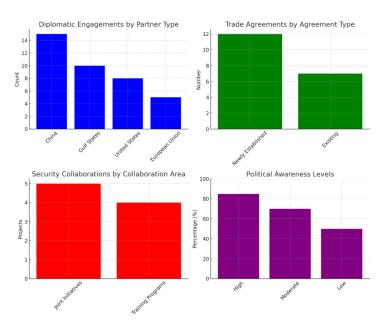


Figure 2: International Relations

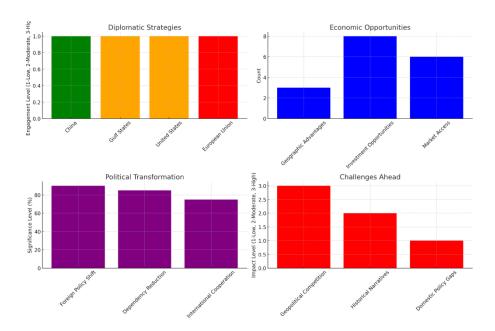


Figure 3: Comparative Analysis

Findings from this dissertation elucidate the evolving landscape of Somalia's foreign relations within the complexities of a multipolar world, emphasizing the necessity for adaptable diplomatic strategies. The research problem centered on how Somalia can effectively engage with multiple global powers while asserting its

sovereignty. This issue was effectively addressed by demonstrating that Somalia's ability to leverage its geopolitical position hinges on diversifying its partnerships and actively participating in regional organizations. The implications of these findings are profound; they contribute academically to the broader discourse on international relations by showcasing the significance of agency for post-conflict states like Somalia in the context of shifting power dynamics. Practically, they offer actionable



insights for Somali policymakers, encouraging engagement proactive diplomatic and partnerships that enhance national interests. As articulated in the assertion that "these actions are not just moral imperatives, they're also practical necessities" "By reaffirming the value of humanitarian aid, by reinforcing access to it, by ensuring humane migration pathways, and by tackling the root causes of crises, we think we can begin to restore balance in the world that desperately needs it." (Morgan Brennan), this underscores the urgency for Somalia to navigate its foreign relations carefully amid rising global interdependence. Future research should focus on longitudinal studies that analyze the impacts of Somalia's foreign relations on economic development and governance, particularly how these strategies influence regional stability. Additionally, examining local perspectives on foreign intervention and cooperation could provide valuable insights into the broader societal implications of Somalia's foreign policy choices. Collaborative ventures in key sectors such as infrastructure, trade, and security, particularly with neighboring states, can significantly enhance Somalia's position in the Horn of Africa. An exploration of how Somalia can balance relationships between competing powers while addressing domestic challenges will contribute further to understanding the complexities of its foreign relations. Ultimately, fostering a robust and nuanced framework for Somalia's diplomacy will not only bolster its

security and economic standing but will also serve as a valuable case study for other nations navigating similar geopolitical environments (Richard C Black et al., 2022), (2020), (Christina C.
